#### 4.0 REGULATORY STATUS

- EA guidelines asap
- CNSC to conduct duty to consult with first nations
- Project description was filed in December 2005
- CNSC & Canadian Environmental Agency have joined forces to create a streamline process
- New template will be used for new build process
- Early 2011 is the time period required to compile all the information
- The aforementioned process will be signed off by the President CEA & Chairperson of the CNSC
- The issue is how do we ensure that the process is followed and in compliance with the various acts
- The Federal Cabinet will make the decision at the end of the day, and thus the social & political policy issues need to be resolved at the EA stage.

- Overall this joint CEA and CNSC panel is viewed as being a positive influence on the EA process for the DGR
- Suggestion that when the commenting period for the new EA is underway the Municipality may wish to comment (EA draft guideline in January/08)
- Of note, the letter signed by all 8 Bruce County Mayors was sent and received by Mr. Baird, Minister of the Environment in regard to the commencement of the EA process for the DGR
- Under the new proposed joint panel the CNSC will provide the technical support

#### 5.0 SITE CHARACTERIZATION PROGRAM UPDATE

- Working with contractors drilling 2 more bore holes to triangulate the site
- Information from the bore holes will be used to support the safety case data
- Will continue consultation with the public to help out with consumer confidence.
- OPG will conduct public attitude research in the Spring of 08
- Council invited to tour
- CNSC EA application is for low & intermediate level waste only
- Shaft design is too small for high level waste
- The agreement prohibits high level waste

#### 6.0 FIRST NATIONS CONSULTATION UPDATE

- OPG has had protocol relations with 1<sup>st</sup> Nations over 10 years
- MOU agreement has been signed with 1st Nations
- Protocol agreement/work plan and the cost to undertake are currently on the table with the 1<sup>st</sup> Nations and OPG.
- The 1<sup>st</sup> Nations have a significant amount of influence in the regulatory process

#### Issues

- Land ownership
- Duty to consult
- Historical rights such as hunting and fishing

### 7.0 NWMO Update

- 1<sup>st</sup> Nations consultation issue exist
- Technical people working on DGR process have come from the original OPG high level waste study group
- NWMO consultation is nation wide Federal & Provincial
- Level dialogue with four provinces discuss how NWMO should implement our plan
- March NWMO will go to the IAC meeting to make a presentation and seek input

- NWMO mandate concentrate on 4 nuclear provinces (Saskatchewan, Ontario, Quebec & New Brunswick)
- May take up to five years to find a willing host community
- A suggestion was made that the DGR Community Consultation Committee should adhere to its mandate and if the NWMO wishes to approach Council for a consultation then they have an option.
- Existing station communities should have an update on a regular basis
- The DGR Community Consultation Committee's mandate was reviewed
