5.0 COMMUNITY SURVEY RESULTS (Marie Wilson, NWMO)

A detailed power point was presented to the Committee by Marie Wilson. Copy of presentation attached to form part of these minutes.

- In the Fall of 2009 a Leadership Survey, Community Survey and Tourist Survey were conducted. The survey research was an

- important component of the EIS socio-economic impact assessment for the L&ILW DGR.
- March 2011 anticipated submission of EIS to Joint Review Panel.
- Visibility of OPG's L&ILW DGR project shown at homeshows with the mobile exhibit, presentations, open houses. Other means of engagement including hosting meetings, discussions and briefings locally and including Bruce County and going as far as the Peninsula.
- Good communication is important to keep community informed.
- Newsletter circulation includes up to 30,000
- Information available on the web site
- Used fuel will not be stored in the DGR.
- NWMO must continue to communicate, educate and build partnerships with the community and more work in Regional Study Area (RSA).

Leadership Survey

- Consisted of cross section of representatives from Businesses, Municipal, Provincial and Federal politicians, Media, municipal administrators and Events Co-ordinators. Structured telephone interviews were conducted with 24 local leaders to receive their views on L&ILWG DGR. Objectives were to identify community issues, determine support for OPG's L&ILW DGR, awareness of NWMO roles and responsibilities and compare to 2006 research.
- Overall Leaders' views reflect the differences between low/intermediate level and high level waste, very familiar and comfortable with L&ILW DGR project. Key community issues of concern were Economic and Healthcare and L&ILW DGR had no impact – not listed as an issue.

Community Survey

- 401 telephone interviews, were conducted in Kincardine (the local study area) and the regional study area included 408 interviews in the neighbouring municipalities of Saugeen Shores, Huron-Kinloss, Arran-Elderslie, Brockton and South Bruce.
 Objectives were to determine any impact of L&ILW DGR, gauge awareness and support for WWMF and OPG's L&ILW DGR.
- Overall the survey showed very positive results. The public perspectives on DGR showed high confidence in safety of L&ILW DGR and level of satisfaction was high. L&ILW DGR had no impact.

> Tourist Survey

- Surveys were distributed/handed out in the area of Inverhuron Provincial Park, MacGregor Point Park and Brucedale Conservation Area.
- Tourists' views indicated that although they were not very familiar with OPG, they were not negatively affected by Bruce Site in their use of the parks and their image of Kincardine and surrounding area will not change. L&ILW DGR had no impact.

6.0 GEOSCIENCE UPDATE (Angelo Castellan, NWMO)

- Predictable geology, examination of drill core
- 34 bedrock formations
- Ground water isolated
- No oil and gas
- Completed 5 & 6 Bore holes. Clean and no issues
- Rock Core Lack of vertical fractures
- Seismically quite site.

- Anticipate submission of EIS in March 2011
- Minimum of six month Public Review period
- Hearing scheduled for late 2011 early 2012
- Anticipate receiving Licence early 2013
- Plan now to be ready if approved for construction. Construction 2013 and five years to service
- Preliminary engineering complete
- Issued Request for Proposal (RFP) Detailed Engineer to complete end of 2011

Metis Nation of Ontairo

- Paper work for agreement currently with OPG
- Metis Nation visited the Bruce site in November to tour the Western Waste Management Facility
- Received presentation on L&ILW DGR
- Meetings with Historic Saugeen Metis to discuss preparing protocol for participation in regulatory review process.
